A senior in high school, Peyton's mother Christy didn't gain much weight while pregnant — so little, in fact, she hid her pregnancy until it came time to deliver. A week shy of her 18th birthday, Christy was taken to the emergency room, claiming she was suffering an appendicitis. The hospital doctors quickly discovered the truth. They immediately prepared for the delivery and birth of Christy's baby. Her 7-pound baby girl was completely healthy. In a whirlwind, Christy's parents arrived at the hospital, totally unprepared to bring home a baby. There was no nursery or diapers, no clothing or formula waiting at home. Overwhelmed, they chose adoption for the baby.
